## Ordinance No. UCC 2015-001

Board held 2<sup>nd</sup> reading of Ordinance No. UCC 2015-001. UNION COUNTY ORDINANCE NO. UCC 2015-001

AN ORDINANCE OF UNION COUNTY, SD, AMENDING THE 2008 REVISED ZONING REGULATIONS FOR UNION COUNTY, SD, BY ADDING CHAPTER 27, RESIDENTIAL DISTRICT (R).

BE IT ORDAINED BY UNION COUNTY, SD:

Section 1. That the 2008 Revised Zoning Regulations for Union County, SD, are hereby amended by adding a chapter to be numbered 27 to read as follows:

#### ARTICLE 27

#### RESIDENTIAL DISTRICT (R)

<u>Section 2701</u>. <u>Intent</u>. This district is intended to provide for areas of residential uses of varying types and other compatible land uses in a pleasant and stable environment. A central sanitary sewer system should be available to serve these developments.

<u>Section 2702</u>. <u>Permitted Uses</u>. A building or premises shall be permitted to be used for the following purposes in the Residential District (R):

- 1. Single family dwelling.
- 2. Public park, playground or swimming pool.
- 3. Neighborhood utilities.
- 4. Church.
- 5. Elementary and high school.

<u>Section 2703</u>. <u>Conditional Uses</u>. A building or premises may be used for the following purposes in the R Residential District if a Conditional Use for such use has been obtained in conformance with the requirements of Section 2204:

- 1. Multiple dwelling.
- 2. Golf course and country club.
- 3. Public utility facility.
- 4. Nursing home.
- 5. Day care center.
- 6. Group day care.
- 7. Group home.
- 8. Bed and breakfast establishment.
- 9. Public utility facility.
- 10. Public facility owned and operated by a governmental entity.

11. Electrical substation.

A.

- 12. Major home occupation in conformance with Sections 140202 and 140203.
- 13. Medical and other health facilities.

<u>Section 2704</u>. <u>Accessory Uses</u>. Accessory uses and buildings permitted in the Residential District (R) are buildings and uses customarily incident to any of the permitted uses in the district. <u>Section 2705</u>. <u>Parking Regulations</u>. All parking within the Residential District (R) shall be regulated in conformance with the provisions of Article 17.

<u>Section 2706</u>. <u>Sign Regulations</u>. Signs within the Residential District (R) shall be regulated in conformance with the provisions of Article 18.

<u>Section 2707</u>. <u>Density, Area, Yard and Height Regulations</u>. The maximum height and minimum lot requirements within the Residential District (R) shall be as follows:

- B. The requirements for a multiple dwelling shall be determined by the conditional use.
- C. There shall be a required front yard on each street of a double-frontage lot. There shall be a required front yard on each street side of a corner lot. One required front yard may be reduced to 12.5 feet on corner lots.
- D. Buildings with side yard setbacks less than required herein, may have additions erected in line with the existing building and provided further that said additions will be erected no closer to the lot line than the existing building.
- E. For a lot located on a cul-de-sac bulb or a curvature which creates a triangular shaped lot, the required lot width will be measured at the required front yard setback line; however, the minimum lot width at the right-of-way line shall not be less than 50 feet.

Motion by Headid, second by Ballard to approve the ordinance with changes recommended during the 1<sup>st</sup> reading.

# Ordinance No. UCC 2015-002

Board held 2<sup>nd</sup> reading of Ordinance No. UCC 2015-002. UNION COUNTY ORDINANCE NO. UCC-2015-002 Ordinance Imposing an Increased Wheel Tax In Union County

Whereas, SDCL 32-5A-1 provides that any county may, by ordinance, impose a wheel tax on all motor vehicles, as defined in § 32-3-1, registered in the county at a rate not to exceed five dollars per vehicle wheel. The tax shall be administered and collected by the county. The total vehicle tax may not exceed sixty dollars per vehicle.

**Now, therefore, be it ordained** by the Board of County Commissioners of Union County that a wheel tax is imposed in and for Union County as set forth herein.

- 1. Pursuant to Ordinance CC 86-001, Union County has been historically assessing this wheel tax upon each vehicle at a rate of four dollars (\$4.00) per vehicle wheel which did not exceed the maximum of sixteen dollars (\$16.00) per vehicle.
- 2. Whereas, pursuant to the statute change to SDCL 32-5A-1, all motor vehicles as defined by SDCL 32-3-1 registered in Union County shall have a wheel tax imposed upon each vehicle at the rate of four dollars (\$4.00) per vehicle wheel, not to exceed the maximum forty-eight dollars (\$48.00) per vehicle.
- 2. The wheel tax shall be collected and administered by Union County.
- 3. The proceeds from the tax created by this ordinance shall be retained by Union County and deposited in the County Road and Bridge fund, and the revenue shall be used only for highway and bridge maintenance and construction.
- 4. The Board of Commissioners of Union County shall, by resolution, establish a means of distributing the revenue generated by this ordinance among Union County and the municipalities and townships located within Union County.
- 5. Upon purchasing a vehicle from a dealer, the purchaser shall pay the appropriate tax at the time of title transfer. Nothing in this ordinance shall prevent an automobile dealer from licensing the vehicles on his lot without paying any wheel tax created by this ordinance.
- 6. If a motor vehicle is licensed for a period of time of less than twelve months, any wheel tax imposed on such motor vehicle pursuant to this ordinance shall be prorated on a monthly basis.
- 7. The wheel tax imposed by this ordinance shall be imposed upon all motor vehicles eligible for license registration or license renewal starting January 1, 2016, and all subsequent months, and every year thereafter.
- 8. Ordinance CC 86-001 shall be replaced by passage of this Ordinance.
- 9. If any provision of this ordinance shall be held invalid, it shall not affect any other provision of this ordinance that can be given effect without the invalid

provision, and for this purpose, the provisions of this ordinance are hereby declared to be severable.
