Motion by Ustad, second by Neely to approve the request to have Don Kniffen cover the VSO office on March 13 and 15 in his absence. The office will be closed on March 20. Carried.

Striping agreement

Motion by Ustad, second by Neely to sign an agreement with the State of South Dakota to provide for the striping of county roads within Union County and for their continuing maintenance. The state has allocated \$500,000 to a state-wide county highway striping project designated as project number P 000S(00)322 PCN 01ER referred to as "PROJECT", STATE funds to pay for 60% of PROJECT cost up to a maximum of \$500,000 with COUNTY funds to pay remainder of PROJECT costs. Union County will be included in the PROJECT for the striping of approximately79 miles of County roads at an estimated cost of \$61,199.60. (County's share-\$43,864.79) Carried.

Motion by Neely, second by Ustad to approve the bid to Triple D Contracting for separation of Sand/Sandbags. Bids were tabulated as follows: Campbell Grading-\$94,410; Lieber Construction-\$47,360; Triple D Contracting-\$32,700; Veit & Company-\$96,310. Carried.

Discussion took place on mitigation grant possibilities. Board agreed that the county should pursue the grants.
