Wellmark Renewal

Gary Welter, Wellmark agent, met with the board to review the renewal rates available for the county employee's group health insurance. Discussion also took place on various changes that will are anticipated in the years ahead. Following discussion,

motion by Neely, second by Ustad to approve the renewal for plans WE7 (8.93% increase) and WE8 (8.59% increase). WE7 plan is the \$1000 deductible plan-\$520.91 single coverage; \$1203.24 family coverage. WE8 plan is the \$1500 deductible plan-\$479.19 single coverage and \$1084.25 for family coverage. County pays for single coverage premium and 50% of the family coverage premium. County reimburses the portion of the deductible when the employee exceeds \$500 of the \$1000 plan and \$1000 of the \$1500 plan. This plan takes effect on May 1, 2013.
