The Union County Board of Commissioners met in regular session on November 12,

Members present were Jordan, Karpen, Neely and Ustad. Schempp absent. Motion by Neely, second by Ustad to approve the agenda as amended. Carried. Motion by Jordan, second by Ustad to approve the minutes of October 29, 2013. Carried.

October Monthly Reports

Veterans Service Officer reported 3 individual contacts. Clerk of Courts reported \$37,469.41 in fines and fees. Register of Deeds' reported \$6,455.50 in transfer tax and \$12,373 in fees. County Nurse \$75 donation Sheriff reported Federal Prisoner & INS room & board fees-\$19,070.13.

Contingency

Motion by Ustad, second by Neely to approve the contingency transfer of \$800 to the Mental Illness board budget. Carried.

Calendar

Motion by Jordan, second by Ustad to close the county offices at 2:00 p.m. for Christmas Eve Holiday. Carried.

Phone system

Board discussed the possibility of purchasing a new phone system. The board visited with States Attorney Miller to discuss what the issue he had with the phone system to contact a phone vendor. It was determined to ask the department heads what features they now have that they would like to keep and what features they would like to see added.

Executive session

Motion by Jordan, second by Neely to enter executive session at 8:57 a.m. for legal purposes. Carried. Chairman declared the board out of executive session at 9:00 a.m.

Dept. head meeting

DOE Steckelberg, Planning director Henze, VSO Veatch met with the board for monthly reports.

<u>Highway</u>

PWA Roggow met with the board to discuss various matters. <u>Sheriff</u>

Motion by Jordan, second by Ustad to authorize the chairman to sign the contract with Brown County for Detention and Brown County Jail rental agreement. Carried.

Discussion took place on the grant received from the state by the sheriff for drug canine. It was agreed that the grant would not be used as an automatic supplement, but the board would grant contingency in the budget if needed for the expenses of the addition of the canine.

Motion by Jordan, second by Neely to approve and authorize travel for three deputies to attend the academy in Pierre. Carried.

Treasurer

Treasurer Hertel presented the board with a tax contract for Todd and Stacey Timperley for delinquent taxes. Motion by Jordan, second by Ustad to allow the treasurer to enter into the contract agreement for payment of tax. Carried.

Chairman declared a recess from 10:27-10:30.

Planning and Zoning fee schedule

John Slattery, attorney, met with the board to discuss what the fee would be if he presented multiple landowners on a petition to change the land parcels that were changed in the Hyperion Zoning back to agriculture.
