### Elected Official Starting Salary

The board discussed the starting salary for the elected positions up for re-election in 2016. Motion by Headid, second by Ballard to set the salaries for newly elected officials as follows: Commissioner- \$11,940; Treasurer- \$46,000; Full-time States Attorney- \$75,000. Carried.

AN ORDINANCE OF UNION COUNTY, SD, ADOPTING THE REVISED OFFICIAL ZONING MAP FOR UNION COUNTY, SD.

### BE IT ORDAINED BY UNION COUNTY, SD:

Section 1. That this Ordinance adopts the revised Official Zoning Map, as set forth in the document titled 2008 Revised Zoning Regulations for Union County; supersedes and replaces the Official Zoning Map adopted by reference in Ordinance No. UCC 2008-002; and repeals any other ordinance or parts thereof in conflict with this Ordinance. Adopted this 24th day of November, 2015.
