General Fund Surplus Analysis

To be in compliance with SDCL 7-21-18.1, it is required to publish in the minutes the total unreserved, undesignated fund balance of the general fund of the county as of March 31 and September 30. This amount may not exceed 40% of the total amount of all general fund appropriations contained in the budget for the next fiscal year. As of September 30, 2011, Union County has \$1,384,785.57 in unassigned funds. This figure is 22.40% of the 2012 General Fund Budget.

Cash Transfer

Motion by Ustad, second by Neely to approve the cash transfer from General Fund to County Road Bridge Fund in the amount of \$681,541, and \$275,000 from the opt-out revenue. Vote 3 aye, 1 nay (Jordan) Motion carried.

Contingency Transfer

Motion by Ustad, second by Neely to approve contingency transfers to the Flood Control Budget-\$2,388; Abused and Neglected-\$10,361 and Court Appointed Attorney-\$2,000. Motion carried.

Boston Mutual Insurance

Discussion took place on Boston Mutual insurance company requesting to meet with employees to allow them to purchase life insurance. It was determined that there would be no mandatory meeting for the initial presentation.

Sheriff
