

Ordinance CC 86-001

An Ordinance Establishing a Wheel Tax for Union County

WHEREAS, pursuant to SDCL 32-5A-1 Union County is authorized to impose a Wheel Tax upon vehicles registered in Union County; and it is the intent of the Commissioners for Union County to impose such a tax under the conditions permitted by said law at this time and to withhold collecting on said tax for the calendar years 1986 and 1987;

THEREFORE, BE IT ORDAINED by Union County South Dakota, there is hereby imposed a Wheel Tax on all motor vehicles, as defined by SDCL 32-3-1, registered in Union County at a rate of \$2.00 per vehicle wheel. The Wheel Tax imposed by this Ordinance shall be the same for all types of motor vehicles and the tax on any one vehicle shall not exceed \$8.00. This tax shall be an annual tax imposed on said vehicles and shall be administered by the Treasurer for Union County.

AMENDMENT TO ORDINANCE CC 86-001

BE IT HEREBY ORDAINED BY UNION COUNTY, SOUTH DAKOTA THAT ORDINANCE CC-86-001 IS HEREBY AMENDED AS FOLLOWS:

WHEREAS, the present wheel tax ordinance for Union County provides for a Two Dollar (\$2.00) per wheel fee on all vehicles in Union County, said ordinance is hereby amended to provide that instead of \$2.00 per wheel the tax shall now be Four Dollars (\$4.00) per wheel and the maximum charge per vehicle is Sixteen Dollars (\$16.00).

IT IS FURTHER, ORDAINED that all funds in excess of \$2.00 per wheel shall be, pursuant to SDCL 32-5A-6, dedicated to and limited to highway purposes.
