Public Auction

A public auction was held to auction the fairground buildings and property as advertised. The fairground buildings were auctioned at the yearly rate and allowed to be pro-rated by month. Tom Farley was the bidder for the Main Exhibit Building @ \$1,000 and the Show Ring @ \$1200; Tom Olson, Farmers Coop Society, was the bidder for the Fairground Parking Area @\$1250. The Beef Barn, Hoop Building, Meeting room, and the vehicle parking area had no bidders and will be available for lease/rental on a first come basis at the prices established by the board of commissioners as advertised. The vacant lot located at North Half of Lot 1 and the North Half, Of the East 46.10 feet of Lot 2 in Block 4, Original Plat of the City of Elk Point had no bid; the 13.006 acres listed as Donnelly Tract One in the SE1/4SW1/4 of Section 20, and in the NE1/4NW1/4 of Section 29, all in T92N, R49W of the 5th PM in Union County, SD was bid on by Casey Westergard at \$225 per acre.

Resolution

Motion by Headid, second by Ballard to approve the following resolution: CAPITAL ACCUMULATION RESOLUTION

#UCC 2015-001

WHEREAS, the county commissioners may authorize the accumulation of funds for a period longer than one year for capital outlay purposes according to SDCL 7-21-51, and WHEREAS, the county does not have the funding available in a single-budget year to pay for the construction of several bridge structures that have become deficient,

WHEREAS, Resolution #UCC 2011-003 for the purpose of setting aside funds during the years 2011-2015 has expired

NOW THEREFORE, BE IT RESOLVED, that the Union County Board of Commissioners do hereby agree to accumulate funds in the General Fund for the purpose of accruing funds to match Federal Bridge Funds and/or Bridge Improvement Grant funds to a maximum accumulation of up to and not to exceed \$450,000.00. Accumulated funds are to be expended for replacement of structures within the next 7 years that are inventoried on the National Bridge Inventory System by SDDOT that are located in Union County.

NOW THEREFORE, BE IT RESOLVED, that the Union County Commissioners do hereby agree to accumulate funds in the General Fund.
