Capitol Accumulation

Motion by Jordan, second by Schempp to place the \$274,258.64 FEMA dollars in the Capitol Accumulation (UCC-2005-27) for the Highway Building. This amount now recovers the \$155,000 used during the 2011 flood (see June 14, 2011 minutes). Motion carried.

Quarterly Supplement

Motion by Jordan, second by Neely to approve the quarterly automatic supplement in the amount of \$1,463 to the Highway Department Budget for insurance on wind damage. Carried.

NOW THEREFORE BE IT RESOLVED, that such provisional budget as amended and all its purposes, schedules, appropriations, amounts, estimates and all matters therein set forth, SHALL BE APPROVED AND ADOPTED AS THE ANNUAL BUDGET OF THE APPROPRIATION AND EXPENDITURES FOR Union County, South Dakota and all its institutions and agencies for calendar year beginning January 1, 2014 and ending December 31, 2014 and the same is hereby approved and adopted by the Board of County Commissioners of Union County, South Dakota, this 19th day of September, 2013. The Annual Budget so adopted is available for public inspection during normal business hours at the office of the county auditor, Union County, South Dakota. The accompanying taxes are levied by Union County for the year January 1, 2014 through December 31, 2014.
