Section 1. That the Land Use Development Ordinance of Union County, South Dakota, be and the same is hereby amended to rezone the following property from Agricultural (AG) to Commercial to wit:

Plat of Lot 1 of Curve Addition, an addition in the NW1/4 NW1/4 8-95-50.

Section 2. The Land Use Administrator is hereby authorized to enter such change upon the official zoning map upon adoption of this amendment.
