The Union County Board of Commissioners met in regular session on April 16, 2013, at the Courthouse in Elk Point, SD at 8:30 a.m.

Members present were Jordan, Schempp, Karpen, Neely, and Ustad. Motion by Ustad, second by Jordan to approve the agenda. Carried. Motion by Neely, second by Ustad to approve the minutes from April 2 and April 9, 2013. Carried.

### March Monthly Report

Register of Deeds' reported \$7,744 in transfer tax and \$13,119 in fees. County Nurse reported \$50 in donations and fees. Federal Prisoner & INS room & board fees-\$10,720.07. VSO officer-9 contacts in March.

### General Fund Surplus Analysis

To be in compliance with SDCL 7-21-18.1, it is required to publish in the minutes the unassigned fund balance of the general fund of the county as of March 31 and September 30. This amount may not exceed 40% of the total amount of all general fund appropriations contained in the budget for the next fiscal year. As of March 31, 2013, Union County has \$2,545,908.90 in unassigned funds. This figure is 37.87% of the 2013 General Fund Budget.

## Cash Transfer

Motion by Neely, second by Schempp to approve the cash transfer from General Fund to Highway Fund in the amount of \$654,106. Carried.

### Personnel

Motion by Ustad, second by Schempp to accept the resignation of Deputy Sheriff Thomas Moore, Jr., effective April 22, 2013. Carried. Board thanks Deputy Moore for his service to the county and wishes him luck in his future endeavors.

It was recommended that Commissioner Ustad come back with recommendations for seasonal/data processing and EMA administrative assistant positions.
