Resolution #UCC 2021-001
UNION COUNTY BOARD OF COUNTY COMMISSIONERS
UNION COUNTY, SOUTH DAKOTA
NO THROUGH TRUCK RESOLUTION

WHEREAS, pursuant to SDCL 7-18A-2, the Union County Board of Commissioners may enact resolutions as may be proper and necessary to carry into effect the powers granted to it by law; and,

WHEREAS, pursuant to SDCL 7-8-20(2), the board of county commissioners shall have the power to make orders respecting the care and preservation of all property belonging to the county; and,

WHEREAS, trucks with heavier loads traveling on county roads, within Union County, South Dakota, have caused significant damage and destruction to the Union County highway system of roads at a significant cost to Union County; and,

WHEREAS, pursuant to SDCL 7-18-8, the adoption of a resolution may take effect immediately for the preservation of the public peace, health, or safety.

NOW THEREFORE BE IT RESOLVED by the Union County Board of Commissioners, that no person may operate a truck with two or more axles upon the Union County highway system within Union County, South Dakota having no origin or destination as evidenced by a bill of lading, along the route traveled; and,

BE IT FURTHER RESOLVED, the Union County Highway Superintendent or its designee shall erect and/or place signage designating any or every portion of the Union County Highway system, as a "No Through Trucks" road; and,

BE IT FURTHER RESOLVED, failure to adhere to this Resolution shall be a violation and result in a fine of \$500.00; and,

BE IT FURTHER RESOLVED that this Resolution shall be effective immediately.
