# **RESOLUTION NO. UCC 2021-005**

WHEREAS, Union County has previously passed an ordinance governing the issuance of Marijuana Licenses in Union County Ordinance UCC#2021-007; and

WHEREAS, UCC#2021-007 is scheduled to become effective on December 15, 2021; and

WHEREAS, UCC#2021-007 section 5.2.2 makes one (1) marijuana dispensary license available to allow the operation of a marijuana dispensary within the county's jurisdiction; and

WHEREAS, UCC#2021-007 section 5.2.3 provides "the Commissioners shall consider all qualified applications in the order they were received, subject to any resolution establishing a different procedure";

NOW THEREFORE BE IT RESOLVED that Union County shall adopt the following procedures for determining the winner of the one (1) available marijuana dispensary license:

- 1. After the County Auditor receives the first application for an available marijuana dispensary license and presents the application to the County Commissioners at the next County Commissioner meeting, the County Commissioners shall only consider applications submitted to the County Auditor before 5:00 pm twenty-seven (27) days after such meeting.
- 2. The county shall only receive one application for each physical location within the county. Any additional applications for the same location shall be automatically denied.
- **3.** All remaining applications shall be placed into a lottery. The first application drawn will be considered the winner of the lottery. The Commissioners shall continue to draw applications out of the lottery to set a priority for alternatives in the event the South Dakota Department

of Health does not approve the winner of the lottery.

- 4. If the winner of the lottery is not approved by the South Dakota Department of Health, each qualifying applicant will be directed to submit their application to the South Dakota Department of Health in the order that they were drawn from the lottery until one of the applicants has been approved or there are no further qualifying applicants.
- 5. At the point the South Dakota Department of Health issues a license to one of the applicants, that application will be considered approved, and the County Commissioner shall decline the remaining applications.
