Proclamation For National Slavery and Human Trafficking Prevention Month

Whereas, the United States was founded upon the principle that all people are created with the inalienable right to freedom, and added the 13th amendment to the Constitution making slavery illegal;

Whereas slavery within the United States today is most often found in the form of forced labor and sex trafficking, which weakens our social fabric, increases violence and organized crime, and debases our humanity;

Whereas this problem is found even within our community;

Whereas every business, community organization, faith community, family and individual can make a difference by choosing products that are not made by forced labor; by working to protect our young people from sexual exploitation; by addressing the problems of internet sex trafficking and pornography; and by becoming more aware of the problem and possible solutions;

Therefore, I, Milton Ustad Chairman of the Union County Commissioner, acknowledge January as Slavery and Human Trafficking Prevention Month, and encourage our citizens to become more familiar with the problem and to work toward solutions.

Resolution #2022-001

Motion by Headid, second by Headid to approve the following Resolution #2022-001

RESOLUTION NO. 2022-001 A RESOLUTION PROVIDING FOR THE ALTERATION OF COUNTY COMMISSIONER DISTRICT BOUNDARIES WITHIN UNION COUNTY, SOUTH DAKOTA.

WHEREAS, Union County is divided into five county commissioners districts that were last defined, established and adopted by Union County Resolution No. 2022-001; and,

WHEREAS, the Union County Board of Commissioners has determined that change in the commissioner districts is necessary in order that each district shall be as regular and compact in form as practicable and contain as near as possible an equal number of residents, as determined by the 2020 Census; and,

WHEREAS, the Union County Board of Commissioners has published notice for and has held the required public hearing; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF UNION COUNTY, SOUTH DAKOTA:

Section 1. County Commissioner districts shall be numbered One through Five, inclusive, and which are identified by number on attached "Exhibit A". The districts shall be described by stating the certain street or avenue designations or other landmarks that divide and border the districts. Any reference to street or avenue below shall mean an imaginary line running down the approximate middle of each street or avenue. The districts of Union County are as set forth below and the map thereof on file in the office of the Auditor. Any discrepancies shall be resolved by reference to the map rather than the physical descriptions set forth herein.

The First District shall include Dakota Dunes West of the Dakota Dunes Boulevard and East and South of North Shay Road and North of Tower Road and West of I-29 and a portion of Dakota Dunes South of Courtyard Drive West of Courtyard Drive and East of Corporate limits of Dakota Dunes. Dakota Dunes East of the Dakota Dunes Boulevard and Dakota Dunes West of Courtyard Drive and East of Wellington Apartments.

The Second District shall include Civil Bend Township, Jefferson City, Brule Township, Spink Township Jefferson Township and a portion of Big Sioux Township that lies North of 334th Street and West of 484th Avenue (this included Sandy Mead and Riverland) and the portion of Elk Point Township West of Hwy 11 and West of I-29.

The Third District shall include North Sioux City Ward 1, Ward 2, Ward 3 and Ward 4 and the portion of Big Sioux Township East of I-29 and South of North Sioux City Limits and the portion of Dakota Dunes that consists of the Wellington Apartments.

The Fourth District shall include Big Springs Township, Sioux Valley Township, Virginia Township and Alcester Township East of Hwy 11. Elk Point City, Richland Township and the portion of Elk Point Township East of Hwy 11 and East of I-29.

The Fifth District shall include Alcester City, Beresford City Ward 1, Ward 2 and Ward 3, Emmet Township, Prairie Township and Alcester Township West of Hwy 11.

Section 2. The alteration of commissioner district boundaries as hereinabove established shall be effective from and after the adoption of this resolution.
