Leave of Absence

If it is necessary, for personal or health reasons, for you to be absent from work for a period greater than three (3) consecutive days, excluding scheduled benefit hours, you must apply for a leave of absence unless you are eligible for benefits under FMLA. Such a request will then be acted upon by the Department Head. The County will consider any request for leave of absence, not to exceed six (6) months.

All leave without pay must be approved by the Department Head or Elected Official. Leave without pay in excess of four (4) weeks must be approved by the County Commission. Leave without pay shall not be granted until all vacation and personal time has been used. No additional leave or other benefits shall accrue during leave without pay.

If an employee accepts employment elsewhere during this leave of absence, they shall be considered to have terminated their leave and have voluntarily quit.

Failure to return from a leave of absence upon its expiration date shall be considered as a resignation and a voluntary quit.

Employees on leave without pay shall contact the Auditor's Office to make arrangements for payment of the employee and employee share of health insurance and other voluntary payroll deductions.
