BRIDGE REINSPECTION
PROGRAM RESOLUTION
FOR USE WITH SDDOT RETAINER CONTRACTS

WHEREAS, 23 CFR 650 Subpart C, requires initial inspection of all bridges and reinspection at intervals not to exceed two years with the exception of reinforced concrete box culverts that meet specific criteria. These culverts are reinspected at intervals not to exceed four years.

THEREFORE, **Union** County is desirous of participating in the Bridge Inspection Program.

The County requests SDDOT to hire <u>Ulteig Engineers</u>, <u>Inc.</u> (Consulting Engineers) for the inspection work. SDDOT will secure federal approvals, make payments to the Consulting Engineer for inspection services rendered, and bill the County for 20% of the cost. The County will be responsible for the required 20% matching funds.

Motion by Dailey, second by Headid to authorize Chairman Ustad to sign ROW Permit for Jefferson Telephone Company is asking to parallel or cross CR #1B, CR #6 and CR #23 with Buried Fiber Optic Cable. Carried.

Motion by Headid, second by Kimmel to approve the Wetland Functional Capacity Unit Credits Sale and Purchase Agreement: Structure 64-134-040; David Liccione, USACE corrected what was figured for the Wetland Credits to require a 5.5 FCUs/acre instead of the 4: as he indicated. Therefore, we will need to purchase an additional 0.81 FCU Credits, purchase price of \$13,000.
