ORDINANCE NO. UCC 2023-003

AN ORDINANCE OF UNION COUNTY, SD, AMENDING THE 2008 REVISED ZONING REGULATIONS FOR UNION COUNTY, SD, BY AMENDING ARTICLE 6: AGRICULTURAL DISTRICT, SECTION 603: CONDITIONAL USES; ARTICLE 14: ADDITIONAL USE REGULATIONS; ARTICLE 17: PARKING AND LOADING REGULATIONS, SECTION 1702: OFF-STREET PARKING REQUIREMENTS; AND ARTICLE 26: DEFINITIONS, SECTION 2602: DEFINITIONS.

BE IT ORDAINED BY UNION COUNTY, SD:

Section 1. That Article 6: Agricultural District, Section 603: Conditional Uses of the 2008 Revised Zoning Regulations for Union County, SD, is hereby amended to include the following:

38. Agricultural Event Venue

Section 2. That Article 14: Additional Use Regulations of the 2008 Revised Zoning Regulations for Union County, SD, is hereby amended to included the following:

Section 1410. Agricultural Event Venues.

- A. Intent. Regulations regarding the development of agricultural event venues are intended to encourage the development of agricultural event venues while protecting the health, safety, and welfare of the public and maintaining the aesthetic integrity of the community.
- B. Small Agricultural Event Venue. Agricultural event venues that allow a maximum of two hundred (200) guests or attendees must meet the following conditions:
 - 1. Located on a minimum parcel size of four (4) acres.
 - 2. Contains an enclosed structure located on the parcel which can accommodate all guests or attendees while complying with all applicable local, state, and federal laws.
 - 3. Provides adequate parking in conformance with Section 605.
 - 4. The parcel immediately connects to an arterial or major collector road as set forth in the current Union County Comprehensive Plan.
 - 5. Number of events held at the agricultural event venue shall be limited to 52 events per calendar year.
 - 6. All noise generating activities, such as music, shall not begin until after 9:00 a.m. and shall cease by 10:00 p.m. or move such activities into an enclosed structure which will reduce the noise level to a minimum of 20 decibels at the event venues exterior property lines.
- C. Intermediate Agricultural Event Venue. Agricultural event venues that allow a maximum of three hundred (300) guests or attendees must meet the following conditions:
 - 1. Located on a minimum parcel size of eight (8) acres.
 - 2. Contains an enclosed structure located on the parcel which can accommodate all guests or attendees while complying with all applicable local, state, and federal laws.
 - 3. Provides adequate parking in conformance with Section 605.
 - 4. The parcel immediately connects to an arterial or major collector road, as set forth in the current Union County Comprehensive Plan.
 - 5. Number of events held at the agricultural event venue shall be limited to 52 events per calendar year.
 - 6. All noise generating activities, such as music, shall not begin until after 9:00 a.m. and shall cease by 10:00 p.m., or move such activities into an enclosed structure which will reduce the noise level to a minimum of 20 decibels at the event venues exterior property lines.

Section 3. That Article 17: Parking and Loading Regulations, Section 1702: Off-Street Parking Requirements of the 2008 Revised Zoning Regulations for Union County, SD, is hereby amended to included the following:

Section 4. That Article 26: Definitions, Section 2602: Definitions of the 2008 Revised Zoning Regulations for Union County, SD, is hereby amended to revise and add the following definitions:

AGRIBUSINESS. Any business establishment including buildings, structures, lots, parcels, or parts thereof which provides services, goods, storage, transportation, or other activities directly related to agricultural production.

AGRICULTURE. The use of land for agricultural purposes including farming, dairying, raising, breeding, or management of livestock, poultry, or honey bees, truck gardening, forestry, horticulture, floriculture, viticulture, and the necessary accessory uses for packaging, treating, or storing the produce providing that the operation of any such accessory use shall be secondary to the normal agricultural activities. This definition shall not include intensive agricultural activities such as concentrated animal feeding operations.

AGRICULTURAL EVENT VENUE. A venue for special functions such as weddings, receptions, meetings, or similar gatherings of people. Must meet the requirements established in Section 1410 for a small or intermediate event venue in the Agricultural District.

ORDINANCE NO. UCC 2023-004

AN ORDINANCE OF UNION COUNTY, SD, AMENDING THE 2008 REVISED ZONING REGULATIONS FOR UNION COUNTY, SD, BY AMENDING ARTICLE 26: DEFINITIONS, SECTION 2602: DEFINITIONS.

BE IT ORDAINED BY UNION COUNTY, SD:

Section 1. That Article 26: Definitions, Section 2602: Definitions, of the 2008 Revised Zoning Regulations for Union County, SD, is hereby amended to revise and add the following definitions:

CEMETERY. A burial ground or graveyard.

CHURCH. A building or structure, or groups of buildings or structures, which by design and construction are primarily intended for the conducting of organized religious services and accessory uses associated therewith.

GARDEN CENTER. A building or premise used primarily for the retail sale of items useful in the culture, display, or decoration of lawns, gardens, or indoor plants, including books, appliances, and tools, but not including power tools or tractors.

GOLF COURSE. A tract of land for playing golf, improved with tees, greens fairways, hazards, and which may include clubhouses and shelters.

HUNTING LODGE. A building or structure used as a temporary shelter or accommodation for hunters as a place to stay, rest, or prepare for hunts.

HUNTING PRESERVE. A property and facilities either privately owned or leased for holding, rearing, releasing, or processing captive-raised game for the purpose of hunting, for a fee, over an extended season.

LIVESTOCK SALES BARN. A structure of premises where livestock is sold on a regular basis to the public.

ROADSIDE STAND. A stand or kiosk located along the side of a road where a person sells, directly to consumers, agricultural products that the person grew, raised, or produced.

SCHOOL, ELEMENTARY, OR SECONDARY (HIGH SCHOOL). Any building or part thereof, whether public or private, which is designed, constructed, or used for instruction in elementary or secondary (high school) education.
