Department Heads Reports

P &Z Scott updated the board with meetings held with Dakota Dunes/TIF's and Building Permits. He also has been updating rural address signage. Building Manager Sexton reported the fire sprinklers for Courthouse and the Sheriff office passed inspection. The final hailstorm damage repair was completed which was the light poles in front of Courthouse. Work was done on the courthouse furnace generator controller and the shelter doors on the generator are rusting and are looking into repairing them. Annual inspection of Courthouse generator done and new computer tower for security doors are part of grant for update. Assessor Bousquet updated the board with the following: Chief Deputy Cooper, Appraiser Scott & Assessor Bousquet attended school in Chamberlain last month. The assessor's vehicle axle shaft is fixed costing \$3,700. Finished building permits for the year and abatements were discussed.

Highway

Hwy. Supt. Jerry Buum met with the board to discuss various matters.

Motion by Dailey, second by Ustad approving the Agri-Business Grant Agreement between the state of South Dakota, Department of Transportation and Union County: This contract is for the re-construction of the County's portion of the Stub-end of CR #15, this is due to the Farmers Co-op Society soybean facility in its current location. This agreement will become effective on the date it is signed. The work contemplated by this Agreement must be completed no later than 04/15/2027. The completion date was moved back a year from the original date of 4/15/2026 due to funds used to replace the bridges on CR #13. Carried.

Motion by Dailey, second by Kimmel approving the Joint Powers Force Account Agreement between state of South Dakota, Department of Transportation and Union County South Dakota: This agreement is to re-imburse the County for damages sustained to the County's Federal Aid Highway System due to a natural disaster, (2024 Flood) with the extent of the damage being identified in the Detailed Damage Inspection Report(s), attached to and incorporated in this agreement. Estimated cost of about \$780,000 in total. Carried.

Sheriff

Sergeant Chief Christie was present. Motion by Kimmel, second by Ustad to approve the Sioux City Humane Society contract. During discussion it was discovered that the contract presented is for Sioux Falls Area Humane Society and the motion was withdrawn by Kimmel and second by Ustad to further clarify the contract.
