ORDINANCE NO. UCC 2025-004 AN ORDINANCE TO AMEND THE 2008 REVISED ZONING REGULATIONS FOR UNION COUNTY, SD, TO REZONE CERTAIN PROPERTY FROM AGRICULTURAL TO PLANNED DEVELOPMENT DISTRICT. BE IT ORDAINED BY THE BOARD OF COMMISSIONERS, UNION COUNTY, SD: Section 1. That the 2008 Revised Zoning Regulations for Union County, SD, be and the same is hereby amended to rezone the following property from Agricultural to Planned Development to wit: SE1/4 SE1/4 of Section 21-89-48 and a portion of SW1/4 SW1/4 of Section 22-89-48, Union County, SD. Section 2. The Planning Director is hereby authorized to enter such change upon the official zoning map upon adoption of amendment.
